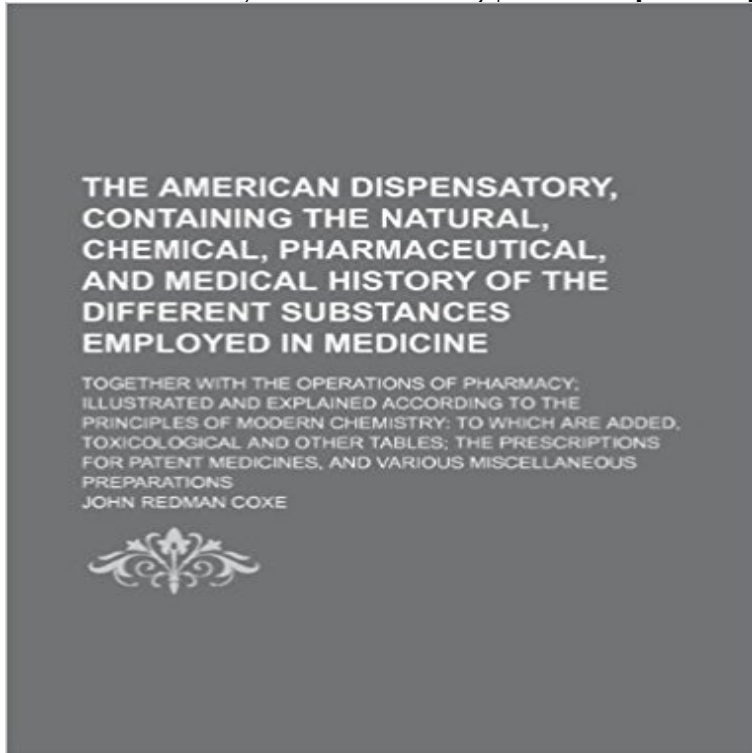

It appears, then, that from the observation of Mr. Pursh, on the living plant, there is no doubt left of the identity of convolvulus jalapa and. ipomaa macrorhiza; and it further appears that as Professor Barton was of opinion that the plant described by Bernard Romans as growing wild near Pensacola, in West Florida, was really the ipomcea macrorhiza of Michaux, we have in addition to the facts adduced by Persoon, Desfontaines and others, the authority of the American Professor to assert that the genuine jalap of the Materia Medica, is a plant indigenous to West Florida and Georgia.
