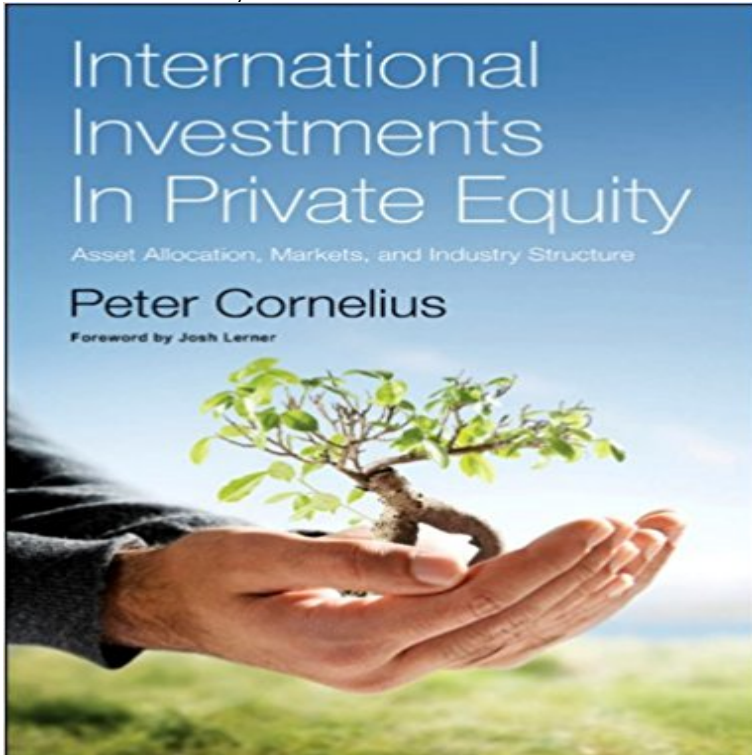


# International Investments in Private Equity: Asset Allocation, Markets, and Industry Structure
